Eastbourne Sport Centre:

Male Wetside - 2 Shower Cubicles (curtains), 2 Toilets, Hand washing Facilities available, 4 Wooden Benches for Seating with hooks on wall - On entry the red fire activation button is easily accessible. Emergency lighting located above the door.

Female Wetside - 2 Shower Cubicles (curtains), 2 Toilets, Hand washing Facilities available, 4 Wooden Benches for Seating with hooks on wall - On entry the red fire activation button is easily accessible. Emergency lighting located above the door.

Wetside Corridor - Fire exit door at back of both male & female change so both parties have multiple exit routes in the event of a fire (route signage + fire action sheet clearly visible), 1 sink for cleaners/staff use to keep facilities clean, Cleaning/Store room both locked and only accessible by authorised personnel.

Wetside Disable - 1 Disabled for everyone - 1 shower with seat + rail, 1 toilet with rail (pull cord by toilet to contact staff in an emergency); 1 Disabled Women's - 3 Showers with rails, 1 toilet with rail; 1 Disabled Men's - 3 Showers with rails, 1 toilet with rail.

Wetside Showers - 8 Showers, signage to show clear pool rules and safety advice for swimmers when entering/exiting the pool areas

Dryside Male - Signage advising users on cleaning + Locker valuable procedure, 4 toilet cubicles, hand washing facilities, 4 urinals (Flushing mechanisms for urinals), 1 water fountain, 6 communal showers of which 1 is disabled with rail, 5 Sets of benches with hooks available if required, Emergency lighting and routes clearly labelled

Dryside Disabled - 1 Toilet with rail (Emergency pullcord by toilet), 1 Baby change unit

Falmer sports centre:

Male change - 8 individual showers, 2 hairdryers, 50 Lockers, 2 sets of hook benches for hanging clothes

Male Toilets - 2 Cubicles, 3 sinks, 2 urinals, 1 hand dryer

Downstairs Disabled - 1 Shower available with assisted rail, 1 toilet with assisted rail, low level sink, emergency pull cord easily accessible from any area

Upstairs Disabled - 1 Shower available with assisted rail, 1 toilet with assisted rail, low level sink, emergency pull cord easily accessible from any area

Falmer sports pavilion: REMOTE (No staff stationed)

8 team changing rooms. Allocated to specific groups with unique code entry. Dead bolt when not use. lighting, flooring, no showers, toilets

2 individual referee

Falmer rugby pavilion: REMOTE (No staff stationed)

2 Remote Changing Rooms (Rugby Pavilion)

Single toilet facility with sink in each changing area

Shower facilities available in each area

Locked by padlock, unless use has been allocated. DO on shift will unlock before use and lock once changing facilities are no longer in use.
